

Independent Auditor's Report on Consolidated Financial Results of the Company Pursuant to the Regulations 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

To the Board of Directors of K2 Infragen Limited (previously known as K2 Infragen Private Limited)

Opinion

We have audited consolidated financial results of K2 Infragen Limited ("the Holding Company") and its associates (the holding Company and its associates together referred to as "the Group") for the six months and year ended 31 March 2024 read with Other Matters section below, both included in the accompanying statement of consolidated financial results for the six months and year ended 31 March 2024 ("the Statement"), attached herewith, being submitted by the Holding Company pursuant to the requirement of Regulations 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ('Listing Regulations').

In our opinion and to the best of our information and according to the explanations given to us and based on the consideration of reports of other auditors on separate audited financial statements of the associates, referred to in Other Matters section below, the Statement:

- i. include the financial results of the following entities.
 - 1) K2 Infragen Limited ('the Holding Company')
 - 2) K2 Recyclers Private Limited
 - 3) K2 Cloud Private Limited
- ii. is presented in accordance with the requirements of Regulations 33 of the Listing Regulations in this regard; and
- iii. gives a true and fair view in conformity with the applicable Indian Accounting Standards prescribed under Section 133 of the Companies Act 2013 ("the Act") as amended, read with relevant rules issued thereunder, and other accounting principles generally accepted in India, of the consolidated net profit and consolidated total comprehensive income and other financial information of the Group for the six months and year ended 31 March 2024.

Basis for Opinion

We conducted our audit in accordance with the Standards on Auditing (SAs) specified under section 143(10) of the Act. Our responsibilities under those Standards are further described in the *Auditor's Responsibilities* section of our report. We are independent of the Group, in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India ("the ICAI") together with the ethical requirements that are relevant to our audit of the consolidated financial results under the provisions of the Act and the Rules thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the ICAI's Code of Ethics. We believe that the audit evidence obtained by us and other auditors in terms of their reports referred to in "Other Matter" paragraph below, is sufficient and appropriate to provide a basis for our opinion.

Management's Responsibilities for the Statement

This Statement has been prepared on the basis of the consolidated annual financial statements. The Holding Company's Board of Directors are responsible for the preparation and presentation of the Statement which includes financial results for the six months and year ended 31 March 2024 that give a true and fair view of the consolidated net profit and consolidated total comprehensive income and other financial information of the Group in accordance with the Indian Accounting Standards prescribed under Section 133 of the Act as amended, read with relevant rules issued thereunder, and other accounting principles generally accepted in India and in compliance with Regulations 33 of the Listing



Regulations. The respective Board of Directors of the companies included in the Group are responsible for maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding of the assets of the Group and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and the design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring accuracy and completeness of the accounting records, relevant to the preparation and presentation of the Statement that give a true and fair view and are free from material misstatement, whether due to fraud or error, which have been used for the purpose of preparation of the Statement by the Directors of the Holding Company, as aforesaid.

In preparing the Statement, the respective Board of Directors of the companies included in the Group are responsible for assessing the ability of the Group to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the respective Board of Directors either intends to liquidate the Group or to cease operations, or has no realistic alternative but to do so.

The respective Board of Directors of the companies included in the Group are responsible for overseeing the financial reporting process of the Group.

Auditor's Responsibilities for the Statement

Our objectives are to obtain reasonable assurance about whether the consolidated financial results for the six months and year ended 31 March 2024 as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. - a) The Statement also include the Group's share of net loss after tax of Rs. 0.42 lakhs and Rs. 4.80 lakhs for the six months and year ended 31 March 2024 respectively, as considered in the Statement, in respect of 2 associates, whose financial statements have not been audited by us. These financial statements have been audited by other auditors whose reports have been furnished to us by the Board of Directors and our opinion on the Consolidated Financial Results, in so far as it relates to the amounts and disclosures included in respect of these entities, is based solely on the report of such auditors and the procedures performed by us are as stated Auditor's Responsibility section above.
- b) The Statement includes the results for the six months period ended 31 March 2024 being the balancing figure between the audited figures in respect of the full financial year and the preceding figures for the six months period from 1 April 2023 to 30 September 2023 which are extracted from the audited restated consolidated financial information prepared for the purpose of Initial Public Offer ('IPO') in accordance with Indian Accounting Standards ('Ind AS') specified under section 133 of the Companies Act, 2013.
- c) Comparative figures for the year ended 31 March 2023 are extracted from the audited restated consolidated financial information prepared for the purpose of Initial Public Offer in accordance with Indian Accounting Standards ('Ind AS') specified under section 133 of the Companies Act, 2013. The statutory consolidated financial statements for the year ended 31 March 2023 were prepared in accordance with the Companies (Accounting Standards) Rules, 2006 which were audited by predecessor auditors who expressed an unmodified opinion on these financial statements vide their audit report dated 11 September 2023.
- d) Corresponding figures for the six months period from 1 October 2022 to 31 March 2023 are based on the group management certified financial information which have not been subjected to limited review / audit.



Our opinion on the Statement are not modified in respect of the above matters.

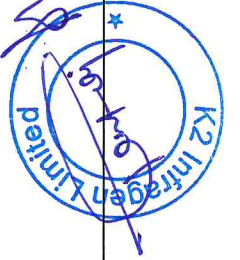

Notes forming part of consolidated financial results for the six months and year ended 31 March 2024

- The above consolidated financial results of K2 Infragen Limited ('the Company or the Holding Company') and its associates (collectively referred to as 'the Group') for the six months and year ended 31 March 2024 have been reviewed by the Audit Committee and approved by the Board of Directors at their meetings held on 27 May 2024. The report is being filed with National Stock Exchange Limited ("NSE") and is also available on the Company's website in compliance with Regulation 33 of the Securities Exchange Board of India ("SEBI") (Listing Obligations and Disclosure Requirements) Regulations, 2015 (as amended).
- The Group has adopted Indian Accounting Standards ("Ind AS") w.e.f., 1 April 2023 (with a transition date of 1 April 2022) and accordingly, these consolidated financial results have been prepared in accordance with applicable Indian Accounting Standards, as notified under the Companies (Indian Accounting Standards) Rules, 2015, and as specified under section 133 of the Companies Act 2013.
- The consolidated financial results for the year ended 31 March 2024 have been audited by statutory auditors under regulation 33 of SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015.
- On 7 August 2023, the Board of Directors of the Holding Company have approved to convert the Holding Company from private limited company to public company. The necessary approvals from registrar of company received and accordingly, status of the Holding Company changed to Public Limited from Private Limited w.e.f. 6 November 2023.
- The Holding Company has completed the initial public offer of ('IPO') 3,406,800 equity shares of face value of Rs. 10 each at the issue price of Rs. 119 per equity share as fresh issue. The equity shares of the Holding Company are listed on National Stock Exchange Limited on 08 April 2024.
- On 20 July 2023, the Board of Directors of the Holding Company has approved the issue of 6,508,551 bonus shares in the ratio of 1:2.90 which has been approved by the shareholders in their extra-ordinary general meeting held on 21 July 2023.
- On 20 July 2023, the Board of Directors of the Holding Company has approved the issue of 458,715 equity shares on preferential/private placement basis at the price of Rs. 119 per share.
- The Group was not mandatorily required to report and publish the results for six months and year ended 31 March 2023 and for the six months period ended 30 September 2023. Comparative figures for the year ended 31 March 2023 and figures for the preceding six months period ended 30 September 2023 are extracted from the audited restated consolidated financial information prepared for the purpose of Initial Public Offer ('IPO') in accordance with Indian Accounting Standards ('Ind AS') specified under section 133 of the Companies Act, 2013.
- Corresponding figures for the six months period from 1 October 2022 to 31 March 2023 are based on the management certified financial information have not been subjected to audit / limited review.
- The results for the six months period ended 31 March 2024 being the balancing figure between the audited figures in respect of the full financial year and the preceding figures for the six months period ended 30 September 2023 (read with note 8).
- The Group is engaged primarily in the business of Engineering, Procurement & Construction and all its operations are in India only. However, till 31 March 2023 the group has another segment relating to sale of products in the subsidiary company. The holding company has diluted the controlling stake in subsidiary company during the year ended 31 March 2023. Accordingly, the below segment disclosure represent figures upto the date of loss of control.

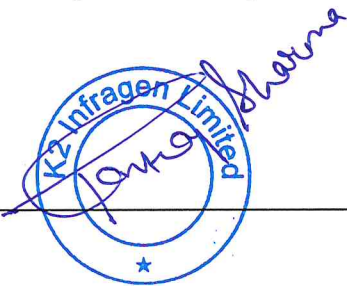


